

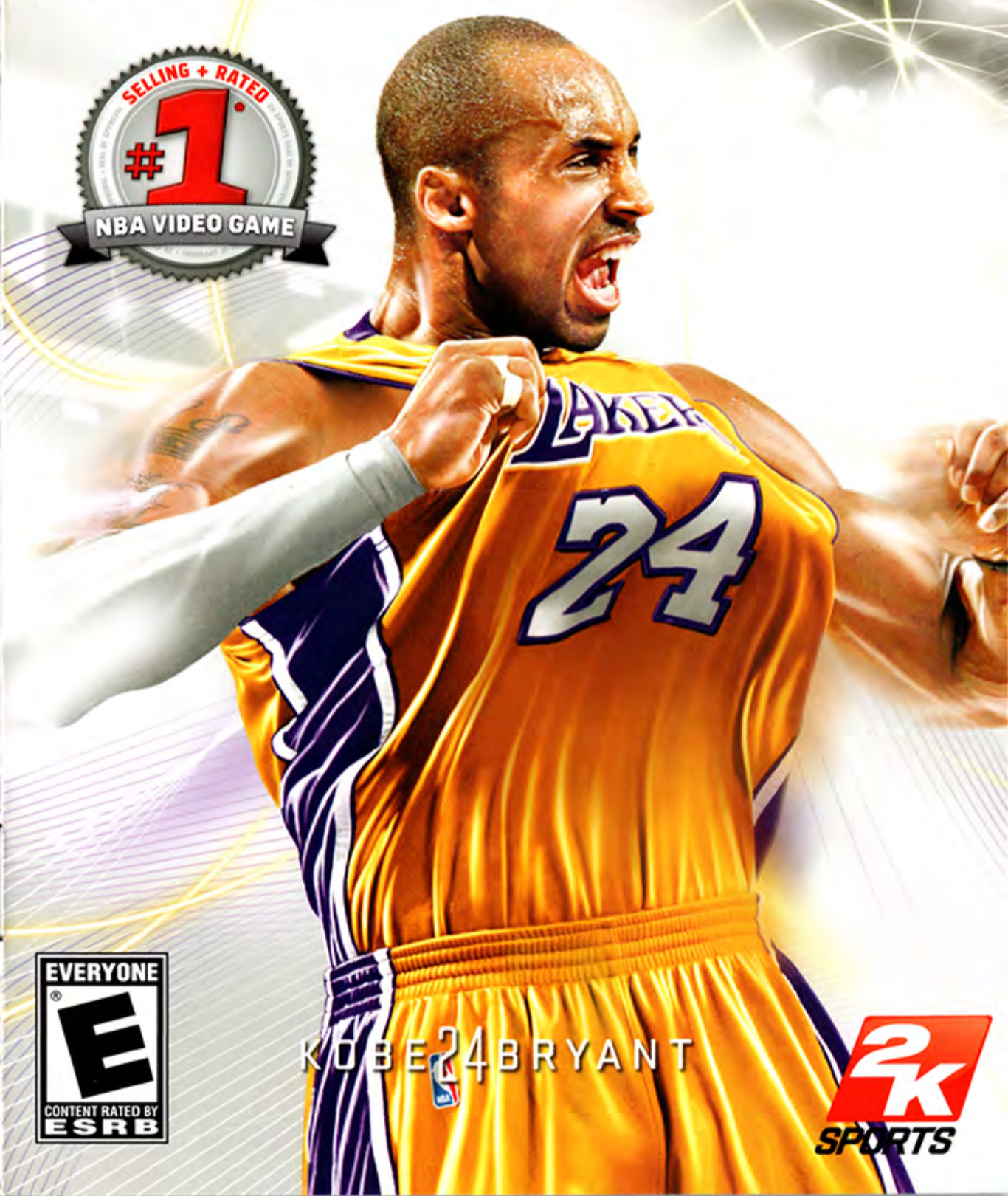

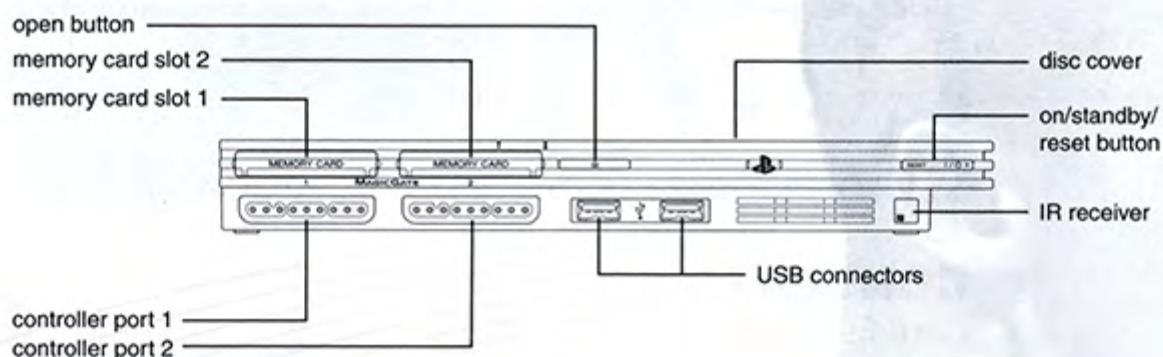

GETTING STARTED



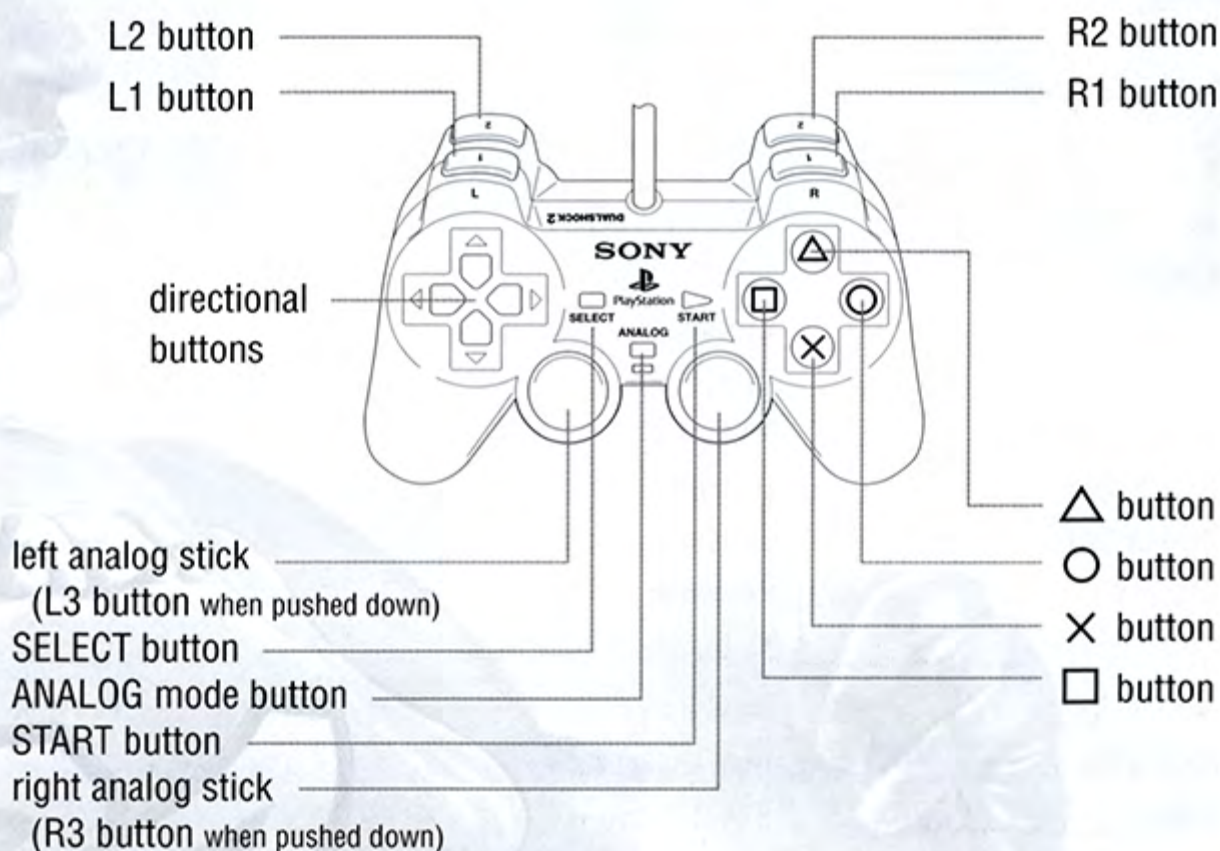
Set up your PlayStation®2 computer entertainment system according to the instructions supplied with your system. Check that the system is turned on (the on/standby indicator is green). Insert the NBA 2K10 disc in the system with the label side facing up. Attach game controllers and other peripherals as appropriate. Follow the on-screen instructions and refer to this manual for information on using the software.

Memory Card (8MB)(for PlayStation®2)

To save game settings and progress, insert a memory card (8MB)(for PlayStation®2) into MEMORY CARD slot 1 of your PlayStation®2 system. You can load saved game data from the same memory card or any memory card (8MB)(for PlayStation®2) containing previously saved games.

MAIN MENU

Once the game loads, press the **START button** and select your Profile to reach the Main Menu.

Quick Game – Hop right into the action! Pick your team and head out to the court.

Game Modes – NBA 2K10's game modes include The Association, Season, Playoffs, Street, Tournament, Practice, and Situation.

Options – Manage your rosters, adjust your gameplay settings, configure presentation options, tweak the NBA rules you play by, and adjust the controller setup.

Features – Setup the VIP, 2K Beats, Arena Music, enter codes, and view the credits.

Load / Save – Load and save your profile, rosters, and rules.

Online – Play against people from around the world online, and get updated rosters.

NBA TRIVIA

Before each game starts, the game will ask you a trivia question as it loads. Test your knowledge of the NBA.

GAME MODES

QUICK MATCH

This is the quickest way to find a game, and allows you to search for ranked matches. The **⊙ button** will return you to the main Online menu. Once a match has been found, you will be brought to the Team Setup screen, which functions the same as it does in Exhibition (select your team, uniforms, etc.)

LOBBIES

Choose from Beginner, Advanced, or the Street Lobby to meet up with friends, scout opponents, and find the match you want. Press the **⊗ button** to send a challenge and press Up / Down on the **right analog stick** to view challenges. The **⊙ button** will return you to the main Online menu. Once you accept a challenge, or your challenge is accepted you will be brought to the Team Setup screen, which functions the same as it does in Exhibition (select your team, uniforms, etc.).

LEADERBOARDS

View the stats leaders of everyone Online! Use the **L2 button** and **R2 button** to scroll the pages UP and DOWN, and press the **○ button** to go back to the main Online menu.

FRIENDS

Choose this option to view your friends list. Highlight any of your friends with UP or DOWN on the **left analog stick**, and press the **⊗ button** to bring up a list of options for that friend. Options include inviting to a game, sending/receiving messages, and removing or blocking people on your friends list.

DOWNLOADABLE CONTENT

Occasionally, updated rosters will be available for download to reflect changes that happen to teams during the basketball season, and those rosters can be downloaded here. Press the **⊗ button** to see a list of available downloads, and the **○ button** to go back to the main Online menu.

NOTE: If you experience difficulty joining an online game in NBA and are using an Internet sharing device (e.g. broadband router or firewall) you may need to enable Port Forwarding (sometimes called Virtual Server) on the device. Please refer to the manual that came with your Internet sharing device for specific setup instructions. You will need to forward both UDP and TCP port to the IP address assigned to your PLAYSTATION®2 console. This may require changing your network settings from an "Automatic" IP address (DHCP) to a "Manual" IP address. NBA 2K10 includes a Network Configuration GUI for setting up and modifying these files. If you continue to experience difficulty joining online games, try bypassing your Internet sharing device by connecting your PLAYSTATION®2 console directly to your DSL or cable modem. In this case, you may need to reconfigure your Network Configuration before your PLAYSTATION®2 console will connect to the Internet.

PAUSE MENU

Access the Pause Menu to alter your game options or to take a quick break. Press **START** at any time in the game to access the Pause menu. Note, only the user in possession of the ball may pause the game. Press the **X button** to select any option.

Resume – Head back to the action.

Replay – See your amazing dunk, behind the back pass, or steal again and again via the Replay system.

Coaching – Customize your team's strategy.

Timeout – Call a timeout and regroup.

Options – Adjust the game options.

Quit – Exit the game

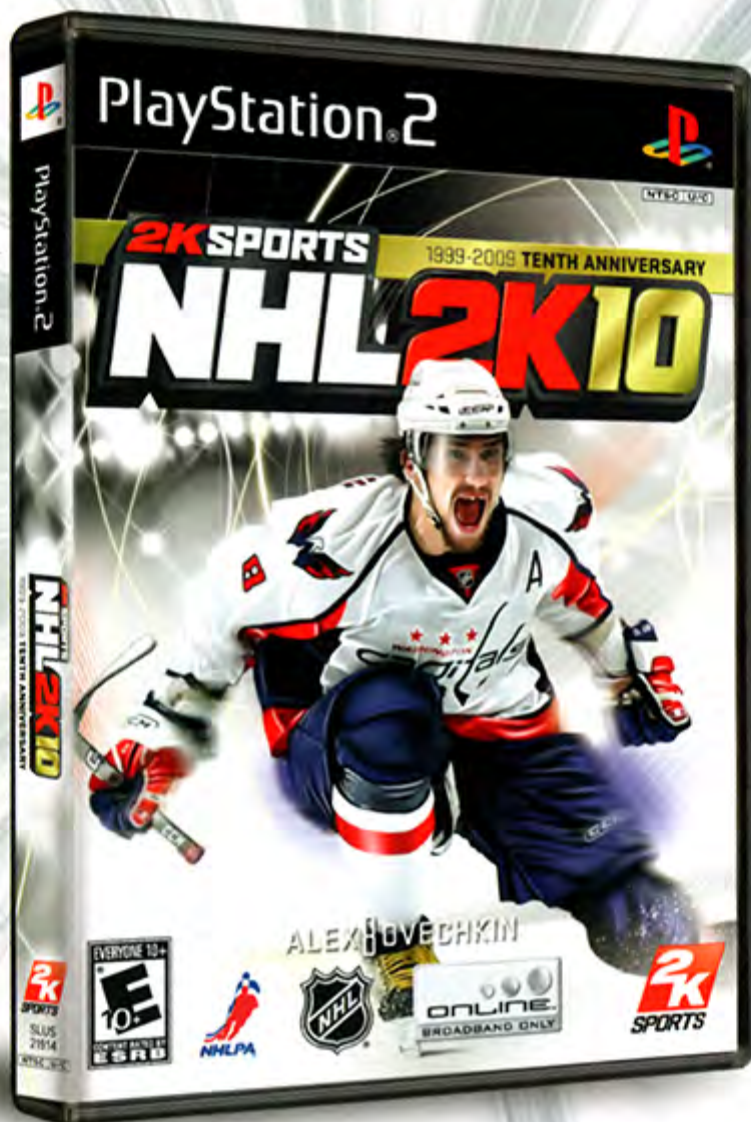
