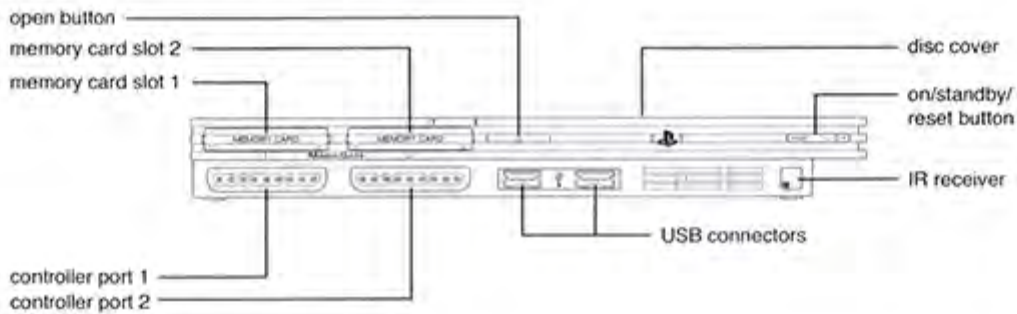
### **HANDLING YOUR PLAYSTATION®2 FORMAT DISC:**

# Getting Started



Set up your PlayStation®2 computer entertainment system according to the instructions supplied with your system. Check that the system is turned on (the on/standby indicator is green). Insert the Pimp My Ride: Street Racing disc in the system with the label side facing up. Attach game controllers and other peripherals as appropriate. Follow the on-screen instructions and refer to this manual for information on using the software.

## Memory Card (8MB)(for PlayStation®2)

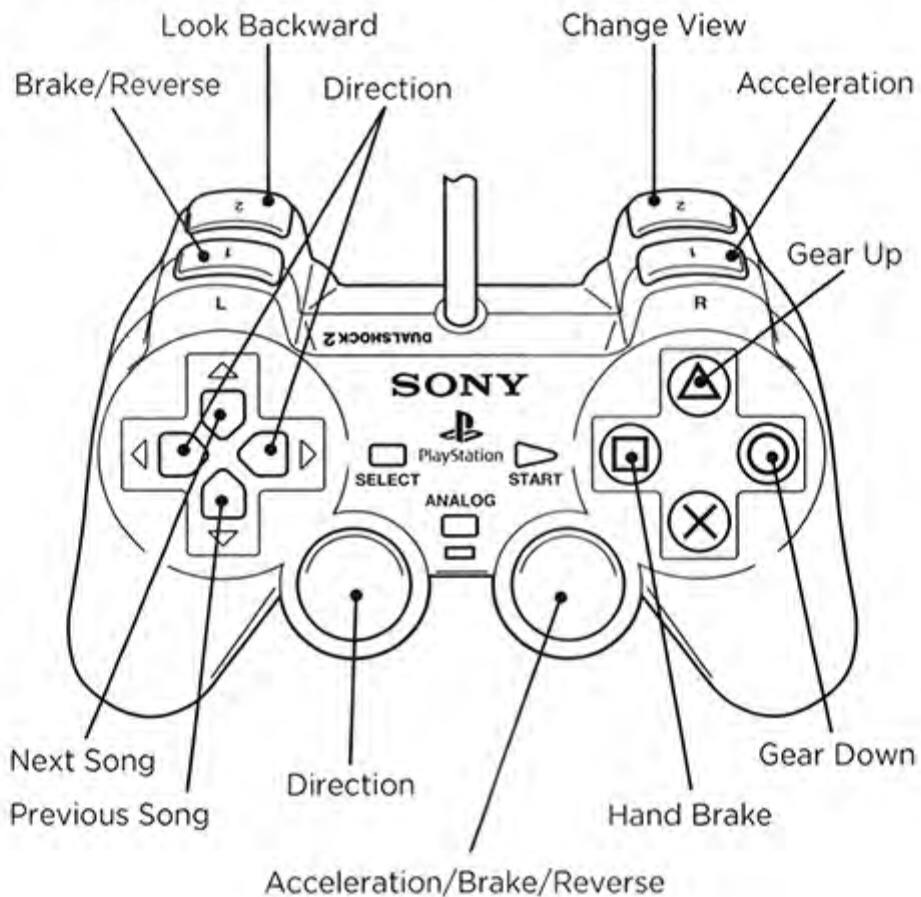

## ***Main Menu***

The Main Menu has the following options to choose from: Championship, Quick Race, Pimp, Options, Hall of Shine and Showcase. Each option is explained in this manual.

**Championship** - In this menu you get to select what race you want to compete in. Each race has three tracks plus a bonus Special Event that you unlock when you win in the other three tracks.

### **Quick Race**

In the Quick Race menu you can play through a selection of race tracks, each with pre-defined car to race with. Place third or better in each race to unlock the next track.

**Pimp** - In this menu you get to change the visual appearance of your car as well as how your car performs.

**Change Car** - In this menu you get to choose the car or truck you want to race with. This is also where you will find the unlocked cars and trucks.

## ***Options***

Here you get to change game settings such as Sound, Vibration, Transmission, Speedometer, Control, Autosave, Profile, and view the names of the people who worked hard to bring you this game in the Credits option.

**Hall Of Shine** - This menu option lists all the special unlocks.

**Showcase** - This is where you get to pan, zoom and turn the camera around your car to see every angle. This is a great way to show off your pimped car to friends.
