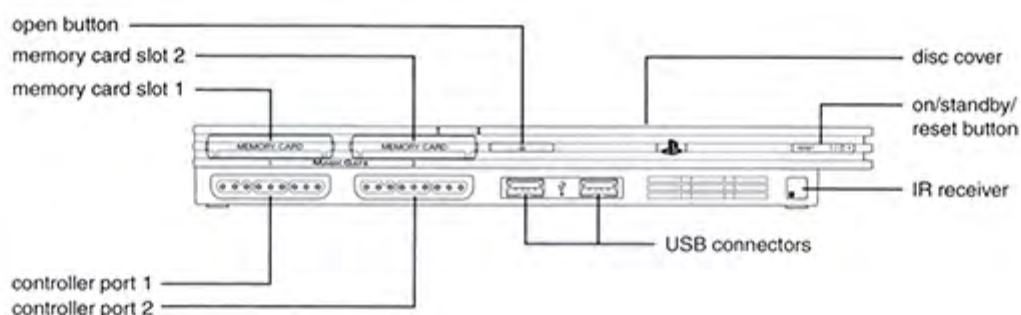
HANDLING YOUR PLAYSTATION®2 FORMAT DISC:

GETTING STARTED



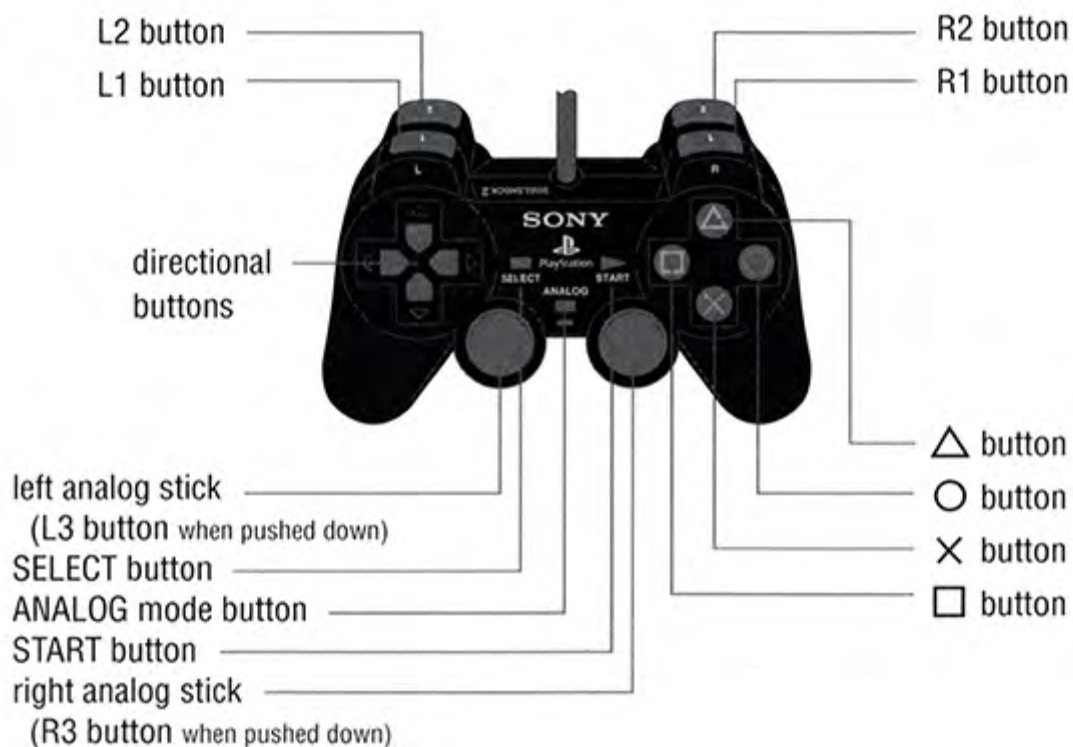
Set up your PlayStation®2 computer entertainment system according to the instructions supplied with your system. Check that the system is turned on (the on/standby indicator is green). Insert the SECRET SERVICE disc in the system with the label side facing up. Attach game controllers and other peripherals as appropriate. Follow the on-screen instructions and refer to this manual for information on using the software.

Memory Card (8MB)(for PlayStation®2)

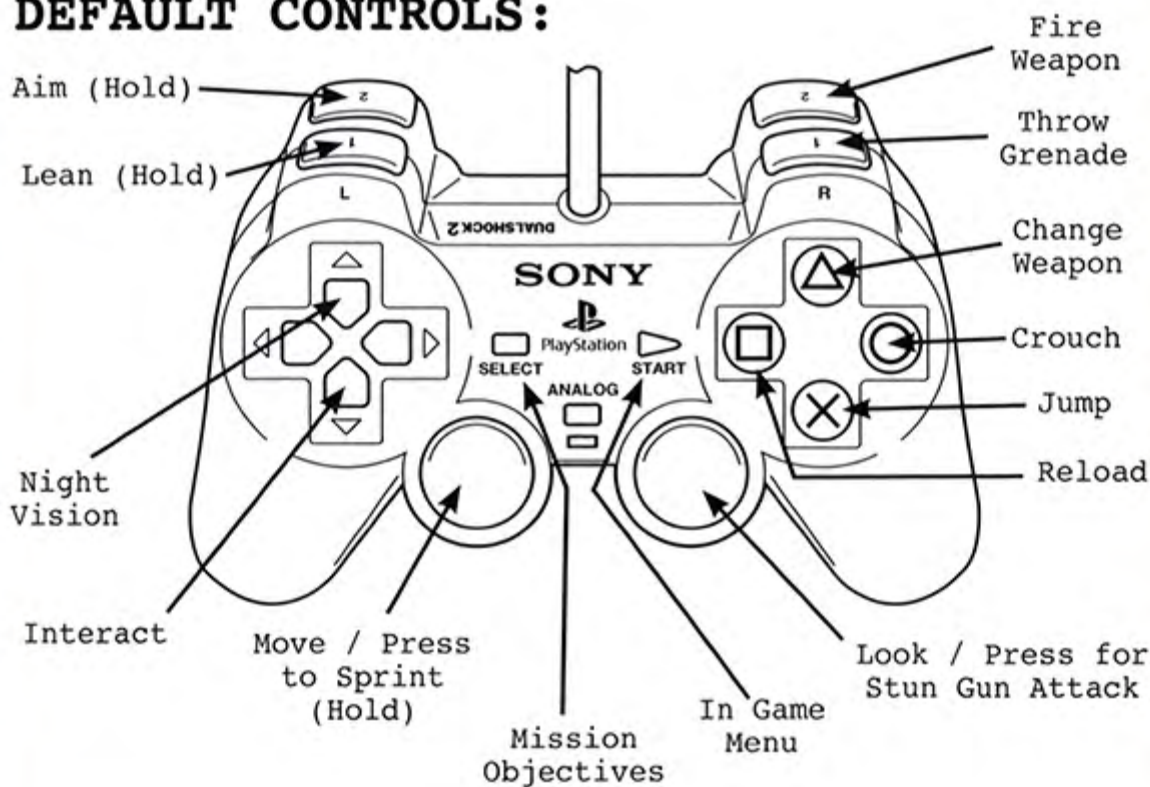
To save game settings and progress, insert a memory card (8MB)(for PlayStation®2) into **MEMORY CARD** slot 1 of your PlayStation®2 system. You can load saved game data from the same memory card or any memory card (8MB)(for PlayStation®2) containing previously saved games.

MAIN MENU

From the Main Menu screen you can choose to play the single player campaign, go into the Options Menu to adjust the game's settings, or go to the Extras screen to play the hacking minigame, listen to your Cell Phone messages, or view the credits.

CONTINUE

Select continue to resume your campaign from the last checkpoint.

START GAME

This menu will allow you to start a new game and also give you access to the levels you have already beaten.

START NEW GAME

Select Start New Game to begin the single player campaign that follows secret service agent Pierce as he uncovers an extremist plot.

DIFFICULTY

There are three difficulty levels in the game Recruit, Agent and POTUS Detail. Agent mode has standard difficulty setting for casual player. Recruit mode is designed for beginners and new comers to the First Person Shooter genre. Enemies cause less damage to the player and the player hits the enemy for more damage than in Agent mode. POTUS Detail mode is for advanced players. Enemies cause much more damage to the player and the player hits enemies for less damage than in Agent mode. POTUS Detail mode is for the player looking for a challenge with a much more realistic damage setting.

MISSION SELECT

This will allow you to replay any level that you have previously completed.

GAMEPLAY



1. **Reticule:** Use this to aim. Press and hold **L2** to look down the sights, increasing your accuracy.
2. **Damage Indicator:** Shows the direction from which you are taking damage.
3. **Current Weapon:** Shows the name of the weapon you are currently using.
4. **Ammo:** Shows how many bullets remain in the current magazine, and how many total bullets you have remaining.
5. **Grenades:** Shows how many grenades you have remaining.
6. **Mission Objectives:** This window shows which objectives have been completed, and which are currently active.
7. **Compass:** This compass shows you where your next objective is located and the distance to that objective. As you get closer to the objective the number will decrease. The dot next to the number will tell you the direction you need to go to reach your objective.
8. **Night Vision Indicator:** This icon tells you how much battery is left for your Night Vision Goggles. When the battery is running low the icon will begin to blink. The battery recharges quickly but you cannot turn the goggles on again while the battery indicator is still blinking.
9. **Stance Indicator:** This icon lets you know whether you are currently standing or crouching.

WEAPONS

You can carry two weapons at a time. Stand over any weapon on the ground and press and hold down on the directional button to switch it with the weapon you are currently holding.

Assault Rifles: Assault Rifles cause moderate damage and have an effective range of close to far. Assault rifles have a medium rate of fire with a mid-rate of recoil.

Shotguns: Shotguns cause high damage but only at close range. At mid to long range these weapons cause very little damage. They have a low rate of fire with a large amount of recoil.

Pistols: Pistols cause moderate to high damage and have an effective range of close to mid. They have a low rate of fire with a small to mid amount of recoil.

Submachine Guns: SMGs cause smaller amounts of damage than assault rifles but have a higher rate of fire. These weapons lose accuracy at long range but have low recoil.

Sniper Rifle: Sniper Rifles cause a high amount of damage and are very effective at long range, but have a high amount of recoil.

Explosive: Explosive weapons fire rockets that explode and cause a large amount of damage to anyone standing near the blast. They have a low rate of fire and long reload times.

SPECIAL WEAPONS

Turret Cameras: These gun mounted cameras are found in the underground levels. When they spot you they will open fire. The best way to take them out quickly is to shoot the red dot on the camera.

Trip Laser Bombs: The enemy has planted Trip Laser Bombs in many areas as defense. You can avoid them or use them to your advantage by shooting at them when enemies are near.

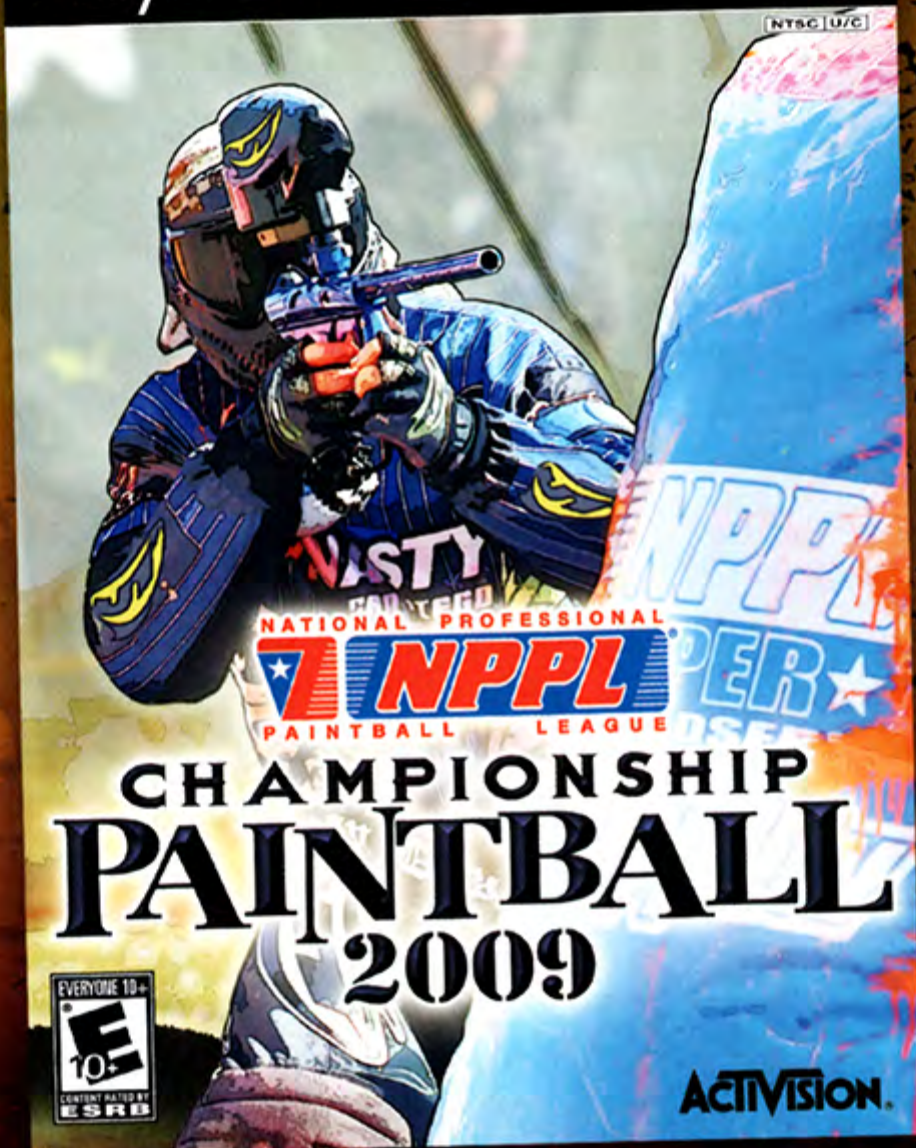

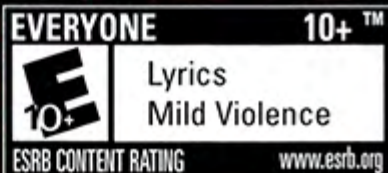
